Fire Prevention in Beaver Creek

As we have indicated in past Newsletters, Beaver Creek has been very active in taking steps to enhance fire prevention activities. Between the Beaver Creek Metro District and the Beaver Creek Resort Company, there has been an investment of almost \$2 million in fire prevention activity. You may have seen the piles of wood ready for a controlled burn when conditions allow. In addition to the major resort-wide actions to minimize fire risk, it is also incumbent of each individual homeowner, condo owner, and townhome owner to have an expert review to assure your property has taken appropriate precautions. Please make sure you do your part. As to the overall fire prevention effort, it is noteworthy that Beaver Creek has been recognized for its fire prevention efforts.



Keep this information handy the next time you are talking to your insurance agent as it may enhance your standing. Thanks to the leadership of the Metro District and the Resort Company for making fire prevention a priority and making resources available to make it a reality.

Creekside Park Renovation

As many of you are aware, the Beaver Creek Resort Company has been pursuing the enhancement of Creekside Park for the benefit of our visitors, homeowners and guests. Experts have been consulted and public comments have been considered in developing the ultimate design for this project. Concerns have been expressed by some of the homeowners living adjacent to the Park and the Resort Company appears to have taken these into account as much as possible. However, they cannot change the fact that the park is where it always has been and unavoidably remains in proximity to various homes. Phase One has received Design Review Board (DRB) approval and Phase Two is to go before the DRB in mid-December. Please see the most recent drawings of the refreshed Creekside Park here.

Speed on Beaver Creek Roads

A consistent concern in Beaver Creek is the safety of all homeowners and guests. Among the many concerns is the speed with which cars, trucks, and buses travel the roadways of Beaver Creek, particularly on Offerson, Village Drive, and across the various crosswalks. Please also keep in mind that there are many people, young and old, who frequent the paths alongside the roadways and have to cross them. Often these crossover points are not easy to see and are even more difficult to address in snowy conditions. **Please be very careful as you drive in Beaver Creek, mind the speed limits, and watch out for pedestrians even if they are not watching out for you.**

Thanks to the neighbors who dedicate hours and expertise to help make Beaver Creek a great place to live, work, and play.

You may or may not be aware that many of the wonderful things that we enjoy and many of the things we take for granted do not "just happen". BC Metropolitan District Update

All regular infrastructure maintenance/repair projects have been completed. Additionally, BCMD has worked on special projects as follows:

Wildfire Mitigation

An additional 482 acres were treated this summer to remove deadfall, standing dead trees, and overgrown underbrush as well as create wild fire-defensible zones. Located primarily on the east side of Beaver Creek, much of this was done on extremely steep, rugged terrain which required considerable hand labor. Approximately 5,500 slash piles will be burned onsite once snow coverage allows.

This concludes the planned wildfire mitigation work and Metro will now transition to an annual maintenance program. Not only has our community been made safer this work has also improved the habitat for wildlife. This effort along with that in Bachelor Gulch and Arrowhead has received national recognition for its excellence. Costs have been shared on a 50/50 basis with BCRC. Additional focus is now required to help safeguard private property. Please have your HOA/property manager arrange a free, no-obligation wildfire safety assessment at

Roadway Lighting

In coordination with BCRC's program to upgrade and unify the lighting in BC Village's public spaces, Metro has replaced all 147 street, intersection, and crosswalk lights with matching hardware. Additionally, a new streetlight has been installed on Offerson Rd. The new lights have a simpler, more contemporary design and are more durable while enabling individually controllable light patterns and providing greater energy efficiency. Summer '24 will see a similar upgrade to the 108 bollards located around the Covered Bridge bus stop and along Village walkways. Bollard and installation costs will be shared on a 60/40 basis with BCRC.

Safety Measures

With the growing popularity of e-bikes, they have become more prevalent on the BC Recreation Path and have raised safety concerns arising from both rider competence and speeds. A variety of speed calming and precautionary measures (warning signs, lane designations, etc.) have been implemented to help ensure the safety of both riders and pedestrians on the path.

Village Connect

On-time performance continues to improve (now at 98% of rides) even as ridership has increased +10.7% versus '22. Additional driver hours and the switch to totally on-demand service has improved system effectiveness and efficiency.

Critically, driver recruitment for the Winter '23-'24 is going extremely well.

Eagle Valley Transit Authority

This new, voter-approved entity continues to ramp up towards total assumption and expansion of the ECO transit system, targeted to be completed in Summer '24.

New for ski season '23-'24, EVTA will add more frequent service on the Beaver Creek -Vail Express route as well as make this route fare-free. That's right, rides will be at no cost (\$0.00) and should provide a great benefit to the Valley's workforce, residents, and visitors.

This enhanced service should noticeably reduce traffic congestion as well as ease parking problems.

Financial Health

BCMD continues to operate with a small, but extraordinarily capable staff of 14. The 2023 operating budget is forecasted to be \$13.3M with cash reserves of \$9.3M.

All snow removal vehicles are ready and eager to roll.

Your property tax bill portion for these Beaver Creek services will increase by 5.4% as controlled by the Denver-Boulder metro inflation rate for 2023.

ERWSD UPDATE

Monthly water and wastewater bills will increase in 2024.We want to help you succeed in using water differently.

Monthly water and wastewater service will increase by 10.9% for a typical customer in 2024, primarily due to ongoing regulatory mandates, aging infrastructure, and to improve system resiliency. We are updating our water use rates to be more equitable as our current tiered rate structure results in larger homes paying less per 1,000 gallons of water than smaller homes for the same amount of water use.

Water use rate structures will change for two account types.

• Individually metered residential accounts: All residential customers with an individual meter will pay the same per volume of use. The amount of water in each usage tier will be the same regardless of home size.

• Irrigation-only accounts: These will be billed based on the total irrigated area. There is no change to the water use rate structure for Commercial, Multi-Family, Municipal, and Mixed-Use account types. These accounts will be updated in the future.



BCRC Civic Assessment Exemption Bylaw Discussion:

The Beaver Creek Resort Company was designed to help Beaver Creek become a refined and vibrant world-class resort community. The functions it is responsible for are: Marketing, Transportation in partnership with BCMD, Municipal Services such as Public Safety and Village Operations, and Community Quality such as Design Review Administration, village events, and capital improvements. The funding for the Resort Company comes from a mixture of assessment sources which include:

Common Assessments are annual fees that could be assessed on valuations of BC property, but in recent years your Board has annually voted to keep this at 0 mills. **Civic Assessment** is a resort fee assessment of 5.35% on all sales within Beaver Creek.

Mountain Special Assessment of 5% on lift ticket sales and on-mountain restaurant revenue in Beaver Creek paid by Vail Corporation.

Real Estate Transfer Assessments (RETA) of 2.375% on every property sale. **Recreation Assessment** of 5% on gross revenues from activities and services not taxable under CO Retail Sales such as golf, tennis and ski lessons.

Lodging Assessment is a special resort fee of .96% on all lodging rental income.

It is the fiduciary duty of the BCRC Board to ensure the economic sustainability of these revenue sources in order to provide all the village services and capital maintenance improvements necessary to keep Beaver Creek a world-class destination for all residents and guests. The Civic Assessment Bylaw specifically allows for an exemption on collecting and remitting this 5.35% on purchases that are shipped out of Beaver Creek. The Board is seeking data and feedback on whether a change to the bylaw eliminating the provision for waived civic assessments on shipped items would have a consequential impact to the Class A residential owners. Unlike a municipality, when goods are shipped and taxes are collected by the

destination, Beaver Creek would never receive any assessments on purchases shipped back into Beaver Creek. Eagle County is the only beneficiary of this destinationsourcing rule because Beaver Creek is within Unincorporated Eagle County and not a taxing entity.

- Examples:
 - *If the purchase is made in Beaver Creek and shipped out of state, no taxes or assessments are collected at the time of purchase from the retailer.
 - For in-state shipping: Purchase made in Vail and shipped to a resident in Denver: Taxed 8.81% for State, County, and Denver tax rate. Purchase made in Denver and shipped to Vail: Taxed 9.4% State, Eagle County, & and Vail tax rate.
 - Purchase made in Beaver Creek and shipped to a resident in Denver: Taxed 8.81% for State, County, and Denver tax rate and <u>NO</u> collection of 5.35% BC Civic Assessment. Purchase made in Denver and shipped to Beaver Creek: 4.9% State & Eagle County tax and <u>NO</u> 5.35% Civic Assessment is collected.
